## 4.5 FIREFIGHTER - SEASONAL

- **4.5.1** <u>POSITION SUMMARY</u> The individual responds to the emergency needs of the citizens of the District and, when not acting in that capacity performs other assigned work which benefits the organization. The primary work activity involves fire suppression and emergency medical treatment. Secondary duties involve activities associated with maintenance and support functions. It is recognized that the secondary duties will involve the majority of physical time spent in the work environment.
- **4.5.2** <u>SUPERVISION RECEIVED</u> This individual operates within the normal chain of command under the direct supervision of the Shift Supervisor on the shift they are assigned to.
- **4.5.3** <u>SUPERVISION EXERCISED</u> May be required to supervise fire fighters, and other support personnel.

## 4.5.4 PRINCIPAL DUTIES & RESPONSIBILITIES:

- A. Responds on district apparatus, to emergency alarms as part of the response team and may be required to perform a wide variety of activities related to that specific response. Activities may include but are not limited to:
  - i. Fire suppression activities
  - ii. Apparatus driver and operator functions
  - iii. Extrication of victims
  - iv. Emergency Medical Technician activities
- B. Will be required to act in a leadership capacity in the absence of a superior officer at emergency incidents.
- C. Will be required to assist in the guidance and supervision of volunteer firefighters in the absence of, or under the direction of a superior officer.
- D. Assist in keeping apparatus and equipment in a state of continuous readiness through participation in post incident clean-up activities, restocking and refueling of apparatus, and routine pre and post incident equipment inspections.
- E. Attends training sessions related to the professional aspects of the position of fire fighter and emergency medical technician.
- F. Performs other related tasks and duties as directed by his/her immediate supervisor.

## **4.5.5** SECONDARY DUTIES & RESPONSIBILITIES:

- A. Is responsible for routine custodial duties as directed by the Operations Chief.
- B. Is responsible for annual hose testing, annual pump testing, annual ladder testing, and annual inventory as directed by the Operations Chief.
- C. Is responsible to carry out assignments as given and report progress and difficulties that arise during minor construction projects.
- D. Performs all other tasks and duties as required by his/her immediate supervisor.

- A. Minimum Required:
  - i. NFPA Fire Fighter 1 or equivalent
  - ii. Current Oregon drivers license
  - iii. NWCG Basic Firefighter Type 2
- B. Additional Desired:
  - i. NWCG Firefighter Type 1 Advanced Firefighter
  - ii. NFPA Pumper Operator
  - iii. Oregon Medical First Responder or EMT Basic
  - iv. Basic skills of light mechanics and carpentry
